Accruals are **Income** received, or **Outgoings** incurred last year that relate to this year and so were carried over to this year and accounted for in this year's accounts, and **Income** received or **Outgoings** incurred this year that relate to next year and will be accounted for in next year's accounts.

Membership subscriptions (and any donations included) for 2022 that were received in 2021 were **accrued** to 2022, and have been added to the total **Income** for this year. Similarly, 2023 subscription/donations received in 2022 have been **accrued** to 2023, and deducted from the total **Income** for this year.

Outgoings incurred in 2021 but relating to 2022, eg, the cost value of sales stock bought in 2021 but sold in 2022, was **accrued** to 2022 and has been added to the total **Outgoings**. Similarly, the cost value of unsold sales stock bought in 2022 has been **accrued** to 2023 and deducted from the total **Outgoings**.

Notes to Balance Sheet

The fact that the books "balance", ie, that the same result for the year-end balance is achieved by, 1) subtracting the Liabilities from the Assets and, 2) by adding the Surplus to the balance at the start of the year, proves that all monies have been accounted for correctly.

"Debtors" refers to income accounted for in the year, not been received or not appearing on the bank statement by the year end. The £40 is a payment for sales in 2022 received on 06-Jan-23.

"Creditors" refers to requests for payment accounted for in the year, not paid or not appearing on the bank statement by the year end. The £28 is a 2022 expenses claim not paid until 06-Jan-23.

"Accrued Outgoings" is an "Asset" because accruing Outgoings to next year increases the balance.

"Accrued Income" is a "Liability" because accruing Income to next year reduces the balance.

Explanation of Stock in Hand as Accrued Cost

The value of unsold stock from this year is treated as a cost that will be incurred next year and is said to be "accrued" to next year. It is therefore subtracted from this year's expenditure.
